## ROSEVILLE ORDINANCE CHAPTER 264 (h) (4) PROVIDES:

A person desirous of placing a political sign shall register his or her intent with the City Clerk prior to the erection of political signs completing the form prescribed by the City Clerk, including the name, address and telephone number of the candidate or person responsible for the placement of political signs, a description of political signs, and adequate details so that they may reasonably be identified, and an attestation that the candidate or person placing the political signs has received permission from the owners of all property on which the political signs will be placed.

H. **Political campaign signs.** Political signs shall be permitted subject to the following:

- (1) No political sign shall exceed 32 square feet of display area unless such sign is the message contained on a permanent approved pylon billboard.
- (2) Political signs are restricted to 32 square feet of display area (per sign) or combination of signs for each 75 feet or portion thereof of property frontage along a public thoroughfare. Where frontage is less than 75 feet, the sign area shall be restricted to 32 square feet for each sign or signs. For corner lots fronting on more than one public way, the longest frontage on a single public way will be used to assess maximum allowable signage. No individual sign in any area, either zoned or used for residential purposes, shall exceed 10 square feet.
- (3) Political signs shall not be erected or placed more than 45 days prior to an election and shall be removed within seven days after the election. Where more than 45 days exist between a primary and general election, signs may not be continuously placed between the primary and general election.
- (4) A person desirous of placing political signs shall register his or her intent with the City Clerk prior to the erection of political signs completing the form prescribed by the City Clerk, including the name, address and telephone number of the candidate or person responsible for the placement of political signs, a description of political signs and adequate details so that they may be reasonably identified and an attestation that the candidate or person placing political signs has received permission from the owners of all property on which the political signs will be placed.
- (5) All signs shall carry the name and address identifying the person placing the sign.
- (6) Political signs shall be constructed of durable materials and constructed so as to avoid collapse from inadvertent contact with wind or weather and shall utilize construction materials and techniques so that no dangerous surface results, including but not limited to protruding nails or sharp edges.
- (7) Political signs shall be placed so as to avoid obstructing the view of vehicular and pedestrian traffic.
- (8) Political signs shall not be located on or project into or overhang any public right-of-way.
