For sidewalk, approach, curb cut and road patch the permit fee includes the initial inspection and one re-inspection. If additional inspections are required, they will be charged at the same rate as the initial permit fee.

Work started prior to obtaining permit will be charged at double the permit fee when permit is obtained.

Concrete must be stamped by the contractor with company name and year.

CONTRACTORS MUST BE REGISTERED WITH THE ENGINEERING DEPARTMENT

Contractors must register each year by providing the following:

1. \$2,000.00 surety bond on **City of Roseville** bonding form
2. \$250.00 cash escrow deposit
3. Copy of their State of Michigan Residential Builders license

REGISTERED SIDEWALK AND APPROACH CONTRACTOR to engage in the business of
installing and repairing sidewalks and approaches in the City of Roseville, Macomb County,
Michigan.

NOW, THEREFORE, THE CONDITION OF THIS OBLIGATION IS SUCH, that if the said
_____ the above bounden shall faithfully observe the
provisions of all ordinances of the City of Roseville concerning the installing and re-installing or
repair of sidewalks and approaches of good material and workmanship and in strict accordance
with all specifications and regulations prescribed by the City Engineer for the construction of
sidewalks and approaches and further if the said bounden principal shall keep all of such
sidewalks and approaches so constructed by him/her in a good condition of repair and fit for
public travel for a period of **five (5) years** after the date of completion of construction of the
same, and further is the said bounden principal shall indemnify and save harmless the City of
Roseville from all damages of every kind and nature caused by negligent or faulty construction
of repair of said sidewalks and approaches then this obligation shall be void, otherwise to
remain in full force and virtue.

This bond shall also be for the benefit of any person, firm or corporation who shall have
suffered any injury or damage by reason of the inferior quality and material or improper
construction of poor workmanship of such sidewalk or approach or for any injury or damage
suffered on account of any sidewalk or approach becoming out of repair within the period of
this bond.
